Return 1033 LESO Equipment

Return any equipment from the 1033 Law Enforcement Support Office (LESO) Program that your agency is no longer using.

Unused equipment is at risk of loss and theft, putting your agency at risk for complying with the program. It also takes up valuable space in your storage area.

To return equipment, follow these steps:

1. Send a list of the items to be returned to our office.
2. Our office will send you the DD1348-1A forms that you will use to return your equipment, usually within a few days.
3. Call the Fort Carson personnel to schedule your drop off time.



4. Return the equipment and get the DD1348-1A form stamped or signed by the Fort Carson personnel.
5. Forward a copy of the signed DD1348-1A to our office by fax or email.
6. Keep the signed DD1348-1A receipt in your files for 5 years.
7. Enjoy your success.

Weapons and DEMIL F items have a different process, which we will handle on a case-by-case basis.

Report Lost and Missing 1033 LESO Equipment

Is your agency missing any equipment from the 1033 LESO Program? Report the loss and get the item removed from your inventory list.

The State Plan of Operation requires law enforcement agencies to report missing equip-

ment to the state office in 24 hours.

We use a [DD200 Financial Liability Investigation of Property Loss form](#) to report the loss to LESO.

On the form, report the item,

the quantity, the circumstances under which the item was lost, and the steps that will be taken to prevent future losses.

While no agency wants to report a lost item, it is preferable to report the loss versus having it discovered by an auditor.

Prevent Lost and Missing 1033 LESO Equipment

Take good care of the equipment that has been loaned to your agency through the 1033 LESO Program.

There are several strategies for preventing equipment loss and theft. Here are some ideas:

- Label 1033 LESO items to ensure that everyone knows that this equipment does not belong to your agency.
- Store 1033 LESO items in a separate location or a specific labelled bin or shelf.
- Store 1033 LESO items in a secure location with controlled access.

- Collect dates and signatures from officers when issuing 1033 LESO items.
- Make a paper trail when issuing 1033 LESO items. The [Equipment Custody Receipt](#) is a template that you can download and modify to suit your needs.
- Keep a list of all of the equipment issued to each officer.
- Take pictures of equipment as it is acquired. Keep the pictures with the 1348 receipts, or the pictures can be uploaded into [LESO FEPMIS](#) in each property record as a reminder of what each item looks like.

- Label 1033 LESO equipment in a central equipment spreadsheet or database. This is also a good place to note the storage location or the issued officer for each item.
- Return unused equipment.

The Law Enforcement Support Office (LESO) within the Department of Defense (DoD), Defense Logistics Agency, facilitates the 1033 LESO program. This program allows transfer of excess DoD property that might otherwise be destroyed to law enforcement agencies across the United States.

Section 1122 of the National Defense Authorization Act authorizes state and local agencies to purchase equipment and supplies in support of counter-drug, homeland security, and emergency response activities through federal sources of supply. Agencies can take advantage of the volume buying power of the Federal Government for low prices.
