Do you want to request items from disposition services locations that are too far away to drive? Do you want to avoid paying for a shipping company to pick up, package, and deliver your items?

Search for and request equipment from a Recycle Control Point (RCP), and enjoy having your equipment shipped direct to your agency at no cost!

RCP locations automatically package and ship equipment directly to your door.

To take advantage, go to <https://business.dla.mil/> and go to LESO Search. Scroll down to search by location. Search in the locations that begin with "RCP."

Just be sure to select from the RCP locations that are in the

1033 LESO Program Annual Inventory Certification Due 12/15/17

As you know, the 1033 LESO Program annual inventory certification process is due Friday 12/15/17.

If any single agency in Colorado has not completed the online certification by the deadline, then the entire state will be suspended from acquiring equipment until the certification is completed by every participating agency.

Statewide accountability benefits every agency. Therefore, one late agency will hold up the entire state. Don't be that agen-

cy!

This is our opportunity to clean up the online records so that they match the physical world. Contact our office to correct any discrepancies between the physical and online inventory numbers.

We have made great progress so far with just a few agencies left to complete the process. Reach out to your neighboring agencies and encourage them to complete the process today.

Two things are necessary to complete the inventory certification:

1. Physical inspection of items on the agency's

1033 inventory list

2. Completion of the online certification on FAMWEB LESO FEPMIS.

After physically inspecting equipment, the simple online process takes about 10 minutes for most agencies to complete.

Request Justifications

Every request for an item through the 1033 LESO Program must be justified, explaining why the agency should be awarded the item.

What makes a good justification? Remember to address **Three Points:**

1. **The item must be for use by the requesting law enforcement agency's officers** (no requesting items to give away).
2. **The item must be for a law enforcement purpose or use** (no requesting items for other purposes).
3. **The justification must be convincing** (make sure the justification matches the item).

Here are some examples of good justifications from Colorado.

Item: Container, K-9 Transport

Justification: This item will be used by our police K9 team for storage of equipment and shelter for dogs during extreme weather conditions .

Item: Unmanned Vehicle (robot)

Justification: Would be used in accordance with PD policy by trained and certified officers. For use in high risk situations where a remote system would eliminate danger to personnel.

Item: Generator Set, Diesel Engine

Justification: This generator will be used by the Sheriff's Office in an emergency shelter or command post during natural disaster response.

The Law Enforcement Support Office (LESO) within the Department of Defense (DoD), Defense Logistics Agency, facilitates the 1033 LESO program. This program allows transfer of excess DoD property that might otherwise be destroyed to law enforcement agencies across the United States.

Section 1122 of the National Defense Authorization Act authorizes state and local agencies to purchase equipment and supplies in support of counter-drug, homeland security, and emergency response activities through federal sources of supply. Agencies can take advantage of the volume buying power of the Federal Government for low prices.

Fun and Games Colorado History Trivia Answer

Answer: From 1890 to 1910, more than 22,400,000 ounces of gold were extracted from 500 mines in the Cripple Creek Mining District, which included Cripple Creek and the neighboring town of Victor.

1900 was a pivotal year from the Cripple Creek Mining District. Gold worth more than \$18 million was mined that year in nearly 500 mines.
